

# THE PONY EXPRESS QUILT CHALLENGE RULES

# **SUMMARY**

Northcott has collaborated with the Pony Express Museum in St. Joseph Missouri to create a fabric collection that honors a unique part of American history - The Pony Express. The collection includes authentic replicas of artwork from the museum.

From September 9-24, 2017 select quilt shops in the original 8 Pony Express trail states (Missouri, Wyoming, Utah, Colorado, Nevada, California, Nebraska and Kansas) will be hosting a block party. During The Pony Express Block Party participating shops will give away a free unique block pattern that they designed using The Pony Express fabric collection by Northcott. Consumers must physically visit participating shops to collect these free block patterns.

Northcott is challenging consumers to put their collected blocks to good use and make a Pony Express quilt!

## **CHALLENGE GUIDELINES**

Consumers can further participate in the Block Party by creating a quilt for a chance to win.

Participating quilts must have a minimum of 6 blocks from 6 different shops in each quilt made with the Pony Express fabric collection by Northcott. (Block patterns can be from the same state).

There is no size minimum or maximum.

Quilts should be completed using any Northcott fabric.

Trims are allowed (Beads, leather, rickrack etc..)

All methods of piecing, applique and quilting are allowed.

Quilt submission must be finished (quilted and bound).

#### **SUBMISSIONS & DEADLINES**

Photo submissions must be sent to <a href="mailto:submissions@northcott.com">submissions@northcott.com</a>. Send the best photo possible. Well lite sharp images help everyone to see your project's details and increase your chances of being noticed by the judges. You can send multiple images to highlight certain elements on your quilt, but it is not mandatory.

Mandatory information needs to be included with your photo submission:

- First and Last Name
- Address
- Phone Number
- Name of shops whose blocks are included in the quilt

Optional information that can be included with your photo submission:

- Story behind your quilt
- Additional contributors
- Any other details you want Northcott to know about

Deadline to submit a photo of a finished quilt is now Sunday November 19<sup>th</sup> at 11:59PM EDT. (This date has been extended from the original November 4th, 2017 deadline).

All quilt submissions will be featured on Northcott's Pony Express Facebook page, for consumers to see all of the amazing Pony Express Block Party quilts!

The top 5 finalists will selected by Northcott. Finalist will be contacted via email and/or phone and will be required to send their quilt to Northcott USA, (1099 Wall Street West, Suite 250, Lyndhurst NJ 07071) for judging.

Quilts will be returned after the challenge is over.

The winner will be announced on Northcott's Pony Express Facebook page by December 17th, 2017.

## NORTHCOTT JUDGING CRITERIA

The Northcott panel of judges will be looking for the following:

- Use of Pony Express Blocks in quilt design- balance, rhythm, harmony and emphasis
- Overall impression- all the elements come together for an eye pleasing affect
- Workmanship- quality and attention to detail
- Creativity- inventive and fun details that make the guilt stand out

# **PRIZES**

- First Place: \$500 USD (cash) and a selection of Northcott fabric with retail value of \$500 USD
- Second Place: Selection of Northcott fabric with retail value of \$250 USD
- Third Place: Selection of Northcott fabric with retail value of \$100 USD

#### PRIZE SUBSTITUTION

Prizes must be accepted as awarded and may not be transferred.

#### **ELIGIBILITY**

Multiple entries from the same person are allowed. Each quilt entry will be judged separately.
